Compensation for other officers or key employees is determined by the CEO and reviewed on an annual basis by the compensation task force. The review includes a comparative analysis of compensation paid by local, sector, and national non-profit organizations. In making such comparisons, job descriptions, special requirements and skills, and the level of complexity and responsibility related to each position are examined. Currently, Can Do MS uses the Colorado Nonprofit Association's salary and benefits survey and the Association for fundraising professionals compensation and benefits study for benchmarking purposes.
